

Terms and Conditions for the Use of Tait Logos

Please read this document before accessing the Tait logos available for download on this website ('Tait Logos'). By accessing the Tait Logos, you agree to be bound by the following terms and conditions. These terms and conditions may be updated by Tait from time to time by posting the updated terms and conditions without prior separate notification to you.

Acceptance

These are the terms and conditions between yourself and Tait Limited having its place of business at 175 Roydvale Avenue, Christchurch 8053, New Zealand ("Tait") concerning the use of the Tait Logos available for download on this website.

Use

Tait authorises you, as a supply partner, to download and use any of the Tait Logos on your website or in printed material for business advertising or promotional purposes only.

Within the scope of the permitted use, the Tait Logos must not be changed or altered in any way. The Tait Logos must always be shown consistently and in accordance with the usage guidelines provided.

The Tait Logos must not be used in a manner that dilutes their value, places Tait or its affiliates in a position of disrepute or causes confusion as to the relationship between you, your company Tait and/or the Tait group of companies. If Tait considers in its sole discretion that any of the Tait Logos is being used in such a manner, you will immediately cease the use of the Tait Logos in the particular manner upon request

You acknowledge and agree that you have no right, title or interest in the Tait Logos other than expressly by these terms and conditions, and that all such right, title or interest in the Tait Logos shall be owned exclusively by Tait. You further acknowledge and agree that nothing in these terms and conditions shall be construed as an assignment or grant you of any right, title or interest in or to the Tait Logos or in any copyright, trade mark or industrial design of Tait save for the limited right granted under these terms and conditions. Tait excludes, to the maximum extent permitted by law, all liability and responsibility for any amount or kind of loss or damage that may result to you or a third party, (including without limitation, any direct, indirect, punitive or consequential loss or damages, or any loss of income, profits, goodwill, data, contracts, use of money, or loss or damages) arising from or connected in any way to the download and/or use, inability to download and/or use or the results of the download and/or use of the Tait Logos.

Termination

Tait reserves the right to request you to immediately stop any use of the Tait Logos if you fail to comply with any of these Terms and Conditions or for any other reason. Upon such request, you shall immediately stop your use of the Tait Logos and immediately destroy all non-published copies of the Tait Logos.

General

The construction, validity and performance of these terms and conditions shall be governed by New Zealand Law, and Tait and you agree to submit to the exclusive jurisdiction of the New Zealand courts.

A failure of Tait to exercise or enforce any right or provision of these Terms and Conditions shall not constitute a waiver of such right or provision and shall in no way affect its right to later enforce or exercise it.

If any provision of these Terms and Conditions is found by a court of competent jurisdiction to be invalid, the parties agree that it shall not affect the validity or enforceability of any other terms or rights which shall continue in full force and effect except for any such invalid or unenforceable provision or part thereof.
